

# **Tutor Guide**

### Introduction

Learning Aid Ohio connects students learning on IEPs (Individualized Educational Programs) with experienced tutors to provide in-person, supplemental support. We leverage the impact of one-on-one instruction to provide meaningful supplemental educational support for learners who need it the most. By serving as a supportive resource outside of the classroom, Learning Aid Ohio plays a critical role in helping learners overcome obstacles, reach their full potential, and achieve academic success.

#### History

Learning Aid Ohio was originally created in response to remote learning during the COVID-19 pandemic. Our program continues today because it has been identified as a valuable supplemental resource for Ohio learners. Learning Aid Ohio provides additional time and focused attention for targeted practice towards educational goals. This continued support not only helps learners academically, but also fosters a sense of confidence and motivation, ultimately contributing to their overall growth and success.

#### How it Works for Learners

Families and learners that meet the program requirements can explore our services and complete an application at **learningaidohio.org** during open enrollment dates. If approved, the applicant learner will receive funding in an online account to spend on sessions with tutors scheduled through **elevatedd.learningaidohio.org**. Account managers can browse the bios of candidates to find a tutor that fits the needs of their learner, schedule a free introductory interview, and start scheduling paid sessions once they have found the tutor they would like to work with. Funds are deducted from the learner's account while payment is made to the tutor by Learning Aid Ohio.

Families must apply each open enrollment period to receive additional funding. Funding awarded for the semester must be used within the given semester dates and expires at the end of each semester. Funding does not roll over.

To qualify for the program, learners must:

- Be served on a current Individualized Education Program (IEP)
- Reside in Ohio
- Meet the 400% or less of the Federal Poverty Level income requirement

#### How it Works for Tutors

Whether a retired teacher or college student studying special education or a related field, our program has a variety of tutors across many age ranges and expertise. Our tutors are independent contractors who provide their own curriculum based on the learner's IEP goals and set their own hours and rate of pay.

Once approved, tutors can set and manage their own schedules and bioadvertising their services and start providing paid, one-on-one tutoring. Whether in the home or a public location like a library, meeting locations are determined and agreed upon between the tutor and the family.

To qualify for the program, tutors must:

- Supply an active ODEW teaching license or a BCI Background Check.
- Plan and provide one-on-one, in-person instruction.
- Commit to providing feedback and communication to the Learning Aid Ohio administration.

#### Program Do's & Don'ts

#### Do

- Do respond to all intro interview and session requests within 72 hours on the ElevateDD Learner platform.
- Do provide services to your clients for the entire session time with the caveat that tutors are encouraged to use the last five minutes of the session to code the session as complete and record notes in the platform. Drive time or session preparation is not included in the duration of the session.
- Do keep your profile and schedule up to date in the ElevateDD Learner platform.

- Do connect with a new learner request as soon as possible providing them with options on how to connect in an introductory session.
- Do ensure each session is held in a one-on-one setting.
- Do respond to requests made by the Learning Aid Ohio team.

#### Don't

- Do not apply for a grant as or on behalf of a family/guardian.
- Do not schedule sessions for or on behalf of a family/guardian.
- Do not attend tutoring sessions that are not booked through the ElevateDD Learner platform. There is zero tolerance for "make-up" or "floating" sessions. You will not be paid for services scheduled outside of the ElevateDD Learner platform.
- Do not work with an individual student for more than 2 hours per tutoring session or more than 3 hours per week.
- Do not bring children or other clients/ learners to sessions.
- Do not perform tutoring sessions during school hours, tutoring should be supplemental and not take place of school instruction.

## Expectations

As a tutor for the Learning Aid Ohio program, you are an influential part of the team and expected to communicate with administration as part of the team.

We understand that life happens, and there may be cancellations from either the family or tutor. We expect that the ElevateDD Learner account and schedule is up to date and accurate.

- Complete three surveys annually
- Comply with regular audits
- Respond to all session requests through the ElevateDD Learner platform
- Respond to all inquiries from the Learning Aid Ohio administration

## Reasons account might be placed in inactive status

- Suspected fraud
- Not responding to our inquiries
- Missing two or more sessions
- Policy violations
- BCI/ODEW not updated

Approximately one month before expiration, Learning Aid Ohio will send a reminder that your BCI or License is due to expire. You will need to provide us with an updated BCI or License by the expiration date. If we do not receive an updated BCI or ODEW License, your Learning Aid Ohio profile will be placed on hold, and you will not be allowed to provide services until your documentation is up to date.

#### Reasons you may be removed from the program

- Applying for, acting as intermediary for or applying on behalf of a learner or family for a Learning Aid Ohio grant.
- Scheduling sessions on behalf of a client.
- Not confirming sessions within 72 hours.
- Providing tutoring services during school hours in the school setting.
- Failing to provide tutoring services in a one-on-one setting.
- Allowing another tutor to provide services in your place.
- Charging more than the hourly rate approved by Learning Aid Ohio.
- Charging Learning Aid Ohio learners a higher hourly rate than other clients.

Violation of the attestation you signed upon application. If you are charged with one of the offenses listed on the attestation you signed during the application process, you must alert Learning Aid Ohio by emailing info@learningaidohio.org. Policy violations.

## **Program Policies**

- 1. Your Ohio Department of Education credentials or BCI Background Check must be current throughout the program. Should they expire, you must submit an updated copy to remain active within Learning Aid Ohio.
- 2. Violation of the Attestation signed upon application: if you are charged with one of the offenses listed on the attestation you signed during the application, you must alert Learning Aid Ohio by contacting info@learningaidohio.org within 14 calendar days.
- **3.** The Learning Aid Ohio platform is only available for individual tutors to offer learners one-on-one tutoring services. Tutors can only apply to Learning Aid Ohio as an individual and not as part of an agency, organization, or company. The person who applies must be the same person who is providing services.

- 4. Immediate family members, and those living in the same household as a learner, cannot apply to tutor their loved one (immediate family is defined as approved parent, grandparent, or sibling by blood, marriage, or adoption).
- **5.** Families on the Learning Aid Ohio program must apply for services through their ElevateDD Learner profile. Tutors cannot apply for, act as intermediary for or apply on behalf of a family.
- 6. All tutoring sessions must be scheduled through the families' ElevateDD Learner account. Do not schedule or hold sessions outside of the ElevateDD Learner platform. There is zero tolerance for "make-up" or "floating" sessions You will not be paid for services scheduled outside of the ElevateDD Learner platform.
- 7. Tutors cannot schedule sessions on behalf of their clients. If it is suspected that a tutor has access to an account manager's account, Learning Aid Ohio reserves the right to remove the tutor and the family from the program.
- 8. Tutors are expected to manage their profile, schedule and services offered through the ElevateDD Learner platform. Failure to update and respond to families through the ElevateDD Learner platform can result in not being paid for services and/or removal from the program.
  - Scheduling requests must be responded to within 72 hours.
  - The session status and session notes must be updated within 48 hours of the completed session.
- 9. Please remember that these grant dollars are intended for one-on-one learning sessions only. They are NOT designed to cover travel time or transportation expenses. We encourage you to use the last five minutes of your session to mark your session "Complete" in the ElevateDD Learner platform and log any session notes.
- **10.** Tutors cannot provide services during school hours or in a school setting.
- **11.** Tutors must provide services in person and in a one-on-one setting.
- **12.** Tutors are not to provide over three hours of paid services to a single client within one week, over two hours in a single session, or four hours of paid sessions to the same household.
- **13.** Tutors are not to charge a lower hourly rate to any client outside of the program.
- 14. If you are a "No-Show" for two or more sessions, we reserve the right to remove you as a tutor from the platform. A "No-Show" is defined as cancellation with less than 6 hours' notice, arrival more than 15 minutes

past the scheduled start time, or failure to show up to the scheduled session.

Please note that some families may choose to meet in a public location. Our cancellation policy is that if a family "no shows" or cancels with less than 6 hours' notice, the tutor is still paid for the session as a courtesy for the short notice cancellation. That said, please complete the following steps in the event of a no-show:

- Contact the family using the contact details provided in the introductory interview.
- Code the session as a "No Show" in the ElevateDD Learner platform. You can also record a note in the system. This will let our team know that you should be paid for the session and that Learning Aid Ohio should follow up with the family.
- Contact Learning Aid Ohio so that we can do a follow-up on our end.
- **15.** Tutor understands grants received by learners are funded by a variety of sources which could include but not limited to foundations, private donors, or federal or state Money.
- **16.** Failure to comply with program policies/agreement could result Learning Aid Ohio in notifying the Ohio Department of Education and Workforce, Attorney General, Office of Professional Conduct, State Auditor, or local law enforcement.

## Pay

Tutors are paid directly by the site administrator only when account manager's schedule paid sessions using their ElevateDD Learner account. We cannot back-pay tutors for any sessions not on the calendar. Please do not accept sessions not documented in the ElevateDD Learner system.

We understand that life happens, and there may be cancellations from either the family or tutor. We require that ElevateDD Learner is accurate. Funds expire at the end of the session and do not roll over into future sessions.

All tutors are independent contractors of Learning Aid Ohio. As a paid independent contractor, you are responsible for filing and paying your own taxes. You will be issued a 1099 tax form digitally through PayChex.

Rate	Qualifications
Up to \$30	High School Diploma/ GED <b>AND</b> 0-10 years of tutoring experience
Up to \$50	Bachelor's degree <b>OR</b> 11-20 years of teaching or tutoring experience
Up to \$75	Master's degree or higher <b>OR</b> 21+ years of teaching or tutoring experience
